

Welcome to Springfield, Missouri and Lake Country Soccer for the 28th annual Ozarks Coca-Cola / Dr Pepper Cup youth soccer tournament.

All games will be played at Lake Country Soccer on the Cooper Sports Complex located at 2334 E. Pythian Drive in Springfield, Missouri. Our tournament operations center is located at our indoor soccer facility at 2334 E. Pythian Drive.

### **CITY & PARK ORDINANCES**

Please be sure to familiarize yourself with our tournament rules of play and facility ordinances. Pay close attention to DOGS which are permitted on site but must be leashed. Pet owners shall be required to "clean up" any dog business as needed. No dogs are allowed in the stadium. Smoking is prohibited on the fields by any person at any time. Alcohol possession and consumption on the property is expressly prohibited as well. These are city and park ordinances.

### **TEAM CHECK-IN**

Check-in will be conducted Friday evening April 20th between 5:00 pm and 8:00 pm at our indoor facility or on Saturday, beginning at 7:00am at our indoor facility. Teams are required to check in no less than one hour prior to your first scheduled game if checking in on Saturday. No need to rush if you can't make it in on Friday. The check-in area is located on the west end of the indoor soccer facility which is located at 2334 E. Pythian Drive in Springfield, MO. 65802

Required documents for check-in include:

- . Approved/official team roster
- . Approved guest player roster form (if using guest players)
- . Approved travel application/travel notification form for all non-Missouri based teams
- . Pass cards for players, coaches and managers who will be in the team bench areas during all games
- . Notarized medical consent & liability release forms (we do NOT keep these documents)
- . Copies of birth certificates for all non-US Youth Soccer affiliated teams (only applies to US Club teams for this tournament)(We do NOT keep copies of birth certificates for tournaments).

Only the team coach OR team manager or other designated adult for the team is required for check-in. Players are NOT required for team check-in.

### **DESIGNATED HOME TEAM v DESIGNATED VISITING TEAM**

Regarding schedules and the designated home team and the designated visiting team: A team's corresponding number on the schedule which is listed first in all match-ups is the designated HOME TEAM. In the event of a color conflict, the designated HOME TEAM shall change jerseys: (for example: 4 v 2 (#4 is the designated home team and #2 is the designated visiting team)).
